Contractor's Description of Service:

Comcast Business DDoS Mitigation Service: Service enhancement to Comcast Managed Internet Service.

- The Comcast Security Operations team can work closely with your business to provide service based on your needs and network information preconfiguring countermeasure options and running acceptance tests for effective mitigation before service activation.
- Monitoring network traffic for a specified set of IP addresses that need threat management and, when a DDoS attack is detected, receive alerts via email and phone. During mitigation, this service diverts traffic directed at the servers, including DDoS attack traffic to cloud-based scrubbing centers distributed across the U.S. The resulting clean and legitimate traffic is simultaneously forwarded to the network and servers through tunneling. This service operates 24x7x365 and helps provide businesses with continued uptime while under a DDoS attack.

Single Incident Service Option: Includes one (1) protection incident per month. A protection incident is a 24-hour time window during which Comcast provides customer with protection against these attacks including mitigation as needed.

Unlimited Service Option: An unlimited number of mitigations in a monthly billing cycle. No incremental mitigation incident fees will be charged with this option. A protection incident is a 24-hour time window during which Comcast provides customer with protection against these attacks including mitigation as needed.

Unlimited Service Option with Automatic Mitigation: With Automatic mitigation, no customer intervention is required. This service automatically initiates mitigation when DDoS attack traffic levels exceed pre-set thresholds of high severity rates and duration. When DDoS attack traffic drops below the thresholds, mitigation terminates automatically. After mitigation is terminated, all traffic is directed back to the Internet connections via normal paths.
